

Resumption of In-Person Meetings; No Further Virtual Stated Meetings

October 14, 2021

Dear Brethren,

During his tenure, Past Grand Master Weiss issued emergency directives allowing lodges to hold virtual stated meetings. His directives were issued pursuant to emergency provisions in the California Masonic Code and in light of the prohibitions against in-person meetings by many California government authorities.

These emergency directives, allowing virtual participation at stated meetings, expired at the close of the Annual Communication on Sunday and now have no force or effect.

This summer, the California Department of Public Health lifted its prohibitions on meeting and events. Counties and cities throughout California have also lifted their meeting prohibitions. I am not aware of any state, county, or city regulation that would prohibit lodges from holding in-person stated meetings (provided, of course, that the meetings are conducted safely and follow guidance with respect to the use of masks, ventilation, proper social distancing, etc.).

Therefore:

There is not cause or justification to renew the directives related to virtual stated meetings issued by Past Grand Master Weiss when he was grand master; and

- Effective immediately, all lodges shall resume in-person stated meetings.
- In-person stated meetings shall be conducted in accordance with state and local guidance regarding the safe conduct of meetings and gatherings.
- All lodges shall cease holding virtual stated meetings and cease allowing lodge members to participate virtually in a stated meeting.

It was wonderful to see many of you at Annual Communication last week and celebrate the vibrant return to the in-person practice of Freemasonry.

In addition to the above, the following actions were also taken:

In accordance with California Masonic Code §801.065, the Grand Lodge granted charters to Benicia Lodge, U.D., The Thirty-Three Lodge, U.D., and Columbia Historic Lodge, U.D., and entered them into the Registry of this Grand Lodge as Benicia Lodge No. 877, The Thirty-Three Lodge No. 878 and Columbia Historic Lodge.

The Grand Lodge approved requests of mutual recognition with the Grand Lodge of Lithuania A.F. & A.M., and the Grand Orient of Rio de Janeiro (*Brazil*).

The Grand Lodge voted to request mutual recognition with the Most Worshipful Prince Hall Grand Lodge of Tennessee.

In accordance with California Masonic Code \$407.050, the Grand Lodge adopted the budget for 2021-2022 as proposed by the Deputy Grand Master. The background check fee was set at \$30.00.

The per capita assessment for the fiscal year November 1, 2022, through October 31, 2023, as proposed by the Senior Grand Warden, was adopted and fixed at \$57.50.

Total registration for the 172nd Annual Communication was 1,002 Master Masons with 251 of 336 chartered lodges represented. (*The number of chartered lodges includes 9 lodges under dispensation, one historic lodge, four research lodges, and Grand Master's Lodge.*)

Next Steps and Summary for Adopted Legislation

October 19, 2021

Dear Brethren,

At the 172nd Annual Communication, legislation was adopted to, among other things, provide lodges with more options regarding stated meeting frequency and dues remissions. I have summarized below the legislation that was adopted and the recommended next steps, if any. I hope this information is useful to you should your lodge decide to implement these new options.

Grand Master's Recommendation No. 1

Actions at the 171st Annual Communication are ratified.

The adoption of this recommendation ratified all the actions taken at the 171st Annual Communication. There is no further action required.

Resolution No. 19-07

Stated meetings may be held less frequently than monthly but no less than quarterly.

The adoption of this resolution amended Section 807.000 of the California Masonic Code to permit lodges to choose the number of stated meetings to hold each year so long as the lodge holds a stated meeting at least quarterly. All lodges must still hold a stated meeting during the months of February and August for the annual and semi-annual reports of the secretary and treasurer, and during the month of November for the election of officers.

A lodge that desires to hold stated meetings less frequently than monthly must amend their lodge bylaws to specify the new meeting frequency. (Lodges whose bylaws provide for monthly meetings fixed by the phase of the moon must continue to hold stated meetings for the transaction of business once in each lunar month.)

A <u>template resolution</u> and <u>certificate of amendment</u> have been developed for the purpose of amending the bylaws to meet less frequently than monthly. These documents can be found on the iMember under Resources/Lodge Administration/Bylaws.

Resolution No. 19-08

Partial remission of dues is now permitted.

The adoption of this resolution amended Section 809.360 of the California Masonic Code, which now allows a lodge, upon recommendation of the charity committee, to remit all, <u>or</u> <u>just a portion</u>, of accrued dues of a Mason who is unable to pay. The lodge may determine how much of the dues are remitted. For example, the lodge may remit 50 percent of the dues or 75 percent of the dues.

Amended Section 407.025 reduces the amount of a lodge's per capita contribution with respect to dues that were partially remitted. The contribution owed by a lodge with respect to partially remitted dues is equal to the percent remitted. For example, if a lodge remitted 50 percent of a brother's dues, the lodge would contribute 50 percent of the per capita due for that member.

In the exercise of this provision, the report of the charity committee should include information about partial remissions. The report should include, without giving the name of the delinquent Masons except to the secretary, full remission of dues for a certain number of brothers and partial remission of dues for a certain number of brothers. For example, "The committee recommends full remission of dues of eight brothers, and partial remission of dues for two brothers." The committee could include the portion of dues remitted in the report if it or the lodge desires. If there is no partial remission of dues, it does not need to be included in the report.

iMember will be updated to allow a secretary or assistant secretary to record the portion of dues remitted, so that the proper per capita calculation can be made. Until the system is updated, the Partial Remission of Dues form must be sent to member services. The <u>partial</u> remission of dues form can be found under Resources/Lodge Administration/Reports and Forms.

Resolution 19-09

Lodges now apply for Annual Communication representative mileage reimbursement.

Section 407.065 of the California Masonic Code now requires a lodge to apply for Annual Communication representative mileage reimbursement. Reimbursement is for the cost of round-trip transportation for one person from the location of the Lodge to the place of the Annual Communication. Lodges must apply no later than 30 days after the close of the Annual Communication, which is November 9, 2021, for this year. This reimbursement form can be found on the member center under Resources/Annual Communication.

NOVEMBER 2021 HOLIDAY OBSERVANCE

11th: Veterans Day

Veterans Day (originally known as Armistice Day) is a federal holiday in the United States observed annually on November 11, for honoring military veterans, who are people who have served in the United States Armed Forces (that were discharged under conditions other than dishonorable). It coincides with other holidays including Armistice Day and Remembrance Day which are celebrated in other countries that mark the anniversary of the end of World War I. Major hostilities of World War I were formally ended at the 11th hour of the 11th day of the 11th month of 1918 when the Armistice with Germany went into effect. At the urging of major U.S. veteran organizations, Armistice Day was renamed Veterans Day in 1954.
